CoNNMO Chair and Secretariat Report October 2020 to June 2021

CoNNMO Council Members

The CoNNMO Council now meets by videoconference four a year, and as required. Council have met twice since the October member meeting.

Council elections

The Secretariat called for nominations for two Council positions in late January 2021. Jo Perks completed her first term and was eligible to nominate. Long standing CoNNMO Council member, Shelley Reid from the Australian College of Neonatal Nurses, completed her third term on Council in December 2020. Shelley was elected to Council in 2014 and has been highly engaged and greatly contributed to the work of Council over the last 6 years. Council extended their sincere thanks to Shelley for her time, effort and expertise. Two nominations for two Council positions were received in February 2021. Jo Perks renominated and Sam Moses (Australian Primary Health Care Nurses Association) nominated for the two positions. Jo and Sam were elected unopposed. A further CoNNMO Council election for two positions will be held in June 2021.

CoNNMO Council Meetings

CoNNMO Council meetings were held by zoom on Friday 20 November 2020, Friday 26 February 2021 and Tuesday 11 May 2021. At the meetings, Council reviewed member body reports from the October 2020 member meeting to identify areas of interest and assist with planning for the upcoming member meeting in June 2021. Potential speakers and invited guests for the member meeting were discussed and agreed. At the meeting in February, Council planned the CoNNMO webinar held in March. The next CoNNMO Council meeting is scheduled to be held by zoom in on 21 September 2021.

CoNNMO Webinar

The second CoNNMO webinar was held on Friday 12 March 2021. A joint presentation was provided by the Australian Government Department of Health Workforce Division and Office of the Commonwealth Chief Nursing and Midwifery Officer on the national nursing and midwifery workforce survey and the national health workforce datasets for nursing and midwifery. Maureen McCarty, Director, Workforce Data, Analysis & Planning, Commonwealth Department of Health and Frances Rice, Senior Nursing and Midwifery Advisor, Chief Nursing and Midwifery Officer Division, Commonwealth Department of Health presented to CoNNMO member representatives and observers. Alison McMillan, Commonwealth Chief Nursing and Midwifery Officer also provided an update on the COVID-19 vaccination program. There were 93 participants at the webinar. The presentation is available on the CoNNMO website under publications. Another CoNNMO webinar will be held at a date to be advised later in the year.

Sotiria Stefanis maintains accounts, financial records and prepares balance sheets for the Department and the external auditors.
