Codes of conduct



Why are the codes important?

The codes

- support nurses and midwives in the delivery of safe
 practice as part of their professional roles
- provide guidance for the public about the standard of conduct and behaviour they should expect from nurses and midwives
- help the NMBA protect the public in setting and maintaining standards to ensure safe practice



The review process

The codes are

- Informed by research
 - Literature review
 - Mapping of codes
 - Notification analysis
- Informed by nurses and midwives
 - Workshops and focus groups
 - Working group and specialist input
 - Preliminary and public consultation



Informed by research

- Literature review
- Mapping of codes
 - Comparative analysis of nursing and midwifery codes
 - Comparative analysis of the codes to multiprofession (common) code
- Notification (complaints) analysis



Key recommendations from literature

- Model the codes on the common codes
- Combine the nursing and midwifery codes
- Include boundaries guidance into the code
- Use second person directive language
- Include guidance on bullying and harassment
- Include guidance on social media



Key findings from mapping

- Codes should:
 - be relevant for all nurses and midwives in both clinical and non-clinical practice
 - include additional requirements for privately practising nurses and midwives
 - include professional boundaries content within the codes



Informed by nurses and midwives

- Working groups and specialist input
 - Key stakeholder bodies
- Workshops
- Focus groups
 - Held in each state and territory
- Consultation



Main features of the new Codes

- Modelled on multi-profession shared code
- Conduct is framed around seven principles,
- The principles are categorised into four domains
- 'Person' is used to refer to the those in a professional relationship with a nurse
- 'Woman' is used to refer to those in a professional relationship with a midwife
- Includes professional boundaries



Codes - 4 Domains

- 1. Practise legally
- 2. Practise safely, effectively and collaboratively
- 3. Act with professional integrity
- 4. Promote health and wellbeing



Practise legally

1. Legal compliance

- Obligations under the National Law including mandatory notifications
- Obligations under other relevant legislation
- Lawful behaviour Expectation to practise honestly and ethically and not engage in unlawful behaviour



Practise safely, effectively and collaboratively

2. Person/woman centred practice

Evidence base, collaborative practice, consent, open disclosure

3. Cultural practice and respectful relationships

- Aboriginal and Torres Strait Islander Peoples health, culturally safe practice
- Effective communication
- Confidentiality and privacy
- End of life care
- Bullying and harassment



Act with professional integrity

4. Professional behaviour

- Professional boundaries
- Advertising
- Conflicts of interest
- Financial arrangements and gifts
- 5. Teaching and supervising
- 6. Research in health



Promote health and wellbeing

7. Health and wellbeing

- Responsibility to maintain health to practise safely and effectively
- Understand and enact the principles of public health e.g. health promotion and vaccination
- Use expertise and influence to protect and advance the health and wellbeing of individuals, communities and populations
